General information

Port of Norrköping (Norrköpings Hamn AB, 556007-2679) is acting as Port Authority in the port area of Norrköping. The company is offering stevedoring and terminal services in its area of activity. Hereafter the Port of Norrköping will be referred to its full name, the Port or the abbreviation PoN.

Unless otherwise agreed, and confirmed in writing by the Port of Norrköping, this Tariff will be applied for all vessel traffic and goods movements to and from the port area. The same will be applied in full to services offered and provided by the Port of Norrköping.

All prices are in Swedish Krona (SEK) and subject to VAT where applicable.

The standard terms of payment is 15 days after the date of invoice.

Thereafter interest is charged in accordance with Swedish interest act.

The ordinary working time is Monday to Friday 07:00-15:30, holidays excluded.

Operations during ordinary working hours: Resources must be ordered no later than 14:30 ordinary business day before the arrival of the vessel.

Cancellation thereafter, later than 15:00 the same day will be charged with 4 hours per man.

Waiting time will be charged by the hour starting from 07:00.

All rates are subject to overtime.

OVERTIME-ORDERS

Monday – Friday overtime must be ordered as soon as possible but no later than 10:00 on the same business day. Overtime must be confirmed no later than 11:30 on the same business day. The order for completion of cargo operations must be confirmed no later than 13:30 on the same business day.

Operations on Saturdays and Sundays must be ordered no later

than two business days prior to the operation. The final order must be received no later than 12:00. Overtime is ordered and invoiced at 6, 8, or 10-hour blocks.

All confirmed overtime will be invoiced.

PORT REGULATION

All vessel related activities are governed by The Port Regulation

TERMS & CONDITIONS

If Port of Norrköping (PoN) fails in the fulfilment of any obligation towards the client, this failure cannot be imputed to PoN, and consequently PoN is not in default, if PoN's fulfilment of that obligation is impeded or rendered impossible by foreseeable or unforeseeable circumstances beyond the control of PoN. Such circumstances include but are not limited to: war, terrorism, pandemics occupation, governmental measures of any nature, natural disasters, fire, explosion, extreme weather, blockades, strikes, shortage of berthing facilities and any other circumstances not reasonably foreseeable by PoN and beyond the control of PoN.

*)The requirements for handling and traceability of ships' waste in Swedish ports will be tightened in accordance with previous EU directives and the Swedish Transport Agency's regulations and general advice on the reception of waste from ships. This will mean new routines and, in some cases, changed handling of waste in Swedish ports. This in turn means that we will need to adjust our port fee to reflect the increased costs that this change entails when the regulation has entered into force. The regulation is still under preparation, but it is highly likely that it will enter into force in the spring of 2023.


